OBJECTIVE OF MOU

The main objective of the MOU is to promote collaboration between "Govt.Kunj Bihari Choubey mahavidyalay lal bahadur nagar" situated at Lal bahadur nagar, Rajnandgaon (C.G.)" and "Govt.Higher Secondary School lal bahadur nagar" situated at Lal bahadur nagar, Rajnandgaon (C.G.)"

1.PROPOSED MODE OF COLLABORATION

"Govt.Kunj Bihari Choubey mahavidyalay lal bahadur nagar" situated at Lal bahadur nagar, Rajnandgaon (C.G.)" and "Govt.Higher Secondary School lal bahadur nagar" situated at Lal bahadur nagar, Rajnandgaon (C.G.)" **propose to collaborate through:-**

- a) Faculty and Students exchange through (Guest Lecture, Workshop)
- b) Any other appropriate mode of interaction agreed upon between Govt.Kunj Bihari Choubey mahavidyalay lal bahadur nagar" situated at Lal bahadur nagar, Rajnandgaon (C.G.) and "Govt.Higher Secondary School lal bahadur nagar" situated at Lal bahadur nagar, Rajnandgaon (C.G.)
- c) Exchange of resource persons.
- d) Implementation of different Socio economic and environmental Projects.
- e) Exchange of ideas and data that are required for conducting Field work, Internship, Practical and project work.
- f) NSS Camp collaboration and Science exhibition.
- g) Motivation for Higher Education.

2. EFFECTIVE DATES AND AMENDMENTS

- a) This MOU shall take effect upon signing by both Parties and shall remain in effect for a period of Two (2) years from the date of signing the agreement unless terminated. Neither party may assign or transfer all or any portion of this MOU without the prior written consent of the other party.
- b) The MOU may be renewed at the end of this period by mutual written agreement by both Parties.
- c) The provisions of this MOU may only be amended or waived by mutual agreement by both Parties.
- d) Any Party may terminate this MOU and any related agreement for any reason by giving thirty (30) days prior written notice to the other Party.

3. RELATIONSHIP

Nothing in this MOU shall be constructed to make either party, a partner an agent or legal representative of the other for any purpose.
